This manual should be treated as a confidential document. The person responsible for downloading or printing out this manual must keep such versions under tight control. Should the manual need to be shown to a production, printing, or other company for the purposes of production, a confidentiality agreement must be concluded with the other party and submitted.

If an affiliated company needs to use the C&B Logo, the section in charge at SUBARU should be consulted with in order to verify that the affiliate has permission to use said logo.

The old "CORPORATE AND BRAND IDENTIFICATION MANUAL APPLIED USAGE EDITION April 2018 Initial Issue" should be destroyed. If this manual is supplemented or revised in the future, please destroy the old version and use the new version.

When using a logo, it must not be copied from an Existing reproduction but reproduced from original data each time.

There are two types of original data: editing and simplified. When using editing data, be sure to provide everything concerning the production work to the producer such as the production company or designer.

Use of simplified data is only allowed in simple cases such as in-house documents where an environment which handles editing data is unavailable.

Use the Recommended Typeface for Added Text and adhere to the isolation rules, following the Signature System for added information (address etc.)







Display the C&B Logo and Corporate Name Logo apart

The C&B Logo and Corporate Name Logo are displayed apart whenever possible to maintain the independence of the C&B Logo.

Decide the positions of the C&B Logo, Corporate Name Logo, and address etc. with reference to the positional relationships indicated in the diagrams on the right.

Apply the Signature System also when creating a layout that separates added elements such as Corporate Name Logo, addresses etc. from the C&B Logo.


Business Card Standard Design Using the C&B Logo

In principle, employ color printing and use Type C-V. Choose white paper whenever possible so the Six Stars Symbol is faithfully reproduced.

Use the Corporate Name Logo (in English) for the company name. The Typeface for Added Text is to be used for other text such as name, department, address, etc.

Caution: The standard position of the name shall be 8mm from the top edge. If there are no obstacles, please follow this pattern.

If this cannot be achieved, adjust the layout appropriately.



If the business card height is other than 55mm, position the C&B Logo so it is visually in the vertical center.

Method to Adjust the Position of the Name According to the Number of Lines for Department/Position Title and Address

[1] If there are many lines for department/position title and address.

Leave a space of 6mm from the top edge of the business card.

[2] If there are few lines for department/position title and address.

Leave a space of 10mm from the top edge of the business card.

Display Area for an Anniversary Logo or Other and Adjustment Method for the Position of the Name

If the anniversary logo or other can comfortably fit in the space to the right of the name using Pattern 1 on page 10, follow the illustration below. However, please pay attention to visual balance so that the anniversary logo does not dominate the C&B Logo. If this cannot be achieved, adjust the layout appropriately.

If the ratio of the length and width of the anniversary logo or other is the same or almost the same, use either the method on this page or Pattern 2 on the next page to achieve the best fit.

Adjustment Method for Long Names

Adjust the letters of the name in accordance with the order of priority below.

[1] Shrink (narrow) the width of the letters of the name.

Method for Displaying an Anniversary Logo or Other, If Does Not Fit Well Using the Pattern on page 11

If an anniversary logo or other does not fit well using the pattern on page 11, lower the position of the name to 14mm from the top edge of the business card. However, please pay attention to visual balance so that the anniversary logo does not dominate the C&B Logo.

If this cannot be achieved, adjust the layout appropriately.

If there are Many Lines for Department/Position Title and Address

If the department/position title and address do not fit when the name is positioned 14mm from the top edge of the business card, position the name 6mm from the top edge, and display the anniversary logo or other on the right of the name following the layout pattern on page 11.

Envelope Design Examples Using the C&B Logo

To avoid interference with addressee information and space for the stamp or postpaid mark, there are two types of design examples for placing the C&B Logo and return address: to the left or at the bottom. When adding other elements or multiple departments, arrange the design examples as appropriate.



The standard for letterheads shall be to display the C&B Logo on the top left, which is the position of visual priority. Variations are available for your convenience, such as for writing address information. Any of these may be chosen. Apply the Signature System to position the Corporate Name Logo and address. This is prescribed for each pattern.

Display Positions of the C&B Logo and Corporate Name Logo on Brochures and the Like

For brochures and the like with multiple pages, display the C&B Logo in one spot on the cover. Choose position with reference to the diagram below. The C&B Logo display position on the back cover is optional and may be omitted.

When there is need to display the full company name, use the Corporate Name Logo either on the back cover of brochure or back side of leaflet and add the address etc. Choose position with reference to the diagram below.

Display the Corporate Name Logo with the head office address etc. in one of the optional positions shown in the diagram.

(Back cover of brochure or back side of leaflet.) It is fine to place the C&B Logo along with address etc. on the front cover or back cover according to page configuration.

Also the company name may be omitted if there is no particular need to display the full company name.

Flat Design C&B Logo Reproduction Methods with Metal / Stone / Wood Materials etc. *Permitted by exception

It is exceptionally allowed to reproduce the Flat Design C&B Logo by processing metal or metallic color materials, wood materials, and stone materials, etc.

This applies when reproduced with techniques such as cutting, channel lettering (box lettering), relief, or etching and mounted on buildings/structures or used for novelty items. However, when reproducing with these methods, decide material and process technique carefully to ensure visibility.

Examples of Permitted Applications

- · When amounted on a building or structure (wall display, exterior, etc.)
- Novelty items
- · Motor show exhibit items and other

Examples of Materials That May Be Used

- (1) Metal, plastic, and other, in a color that is as silver as possible (avoid colors such as gold, copper, bronze, etc.)
- (2) Stone, glass, wood materials, and other (especially in a natural, non-dyed color, but must be solid or almost solid without a prominent pattern; color that is natural as much as possible without tones such as red/yellow/green; transparent items such as glass are permitted.)

In principle, (1) and (2) above are to use the same material for the background and reproduce the Logo with techniques such as cutting, channel lettering (box lettering), relief, or etching.

Refer to "SUBARU Goods Guidelines" for how to reproduce C&B Logo on Clothing, Bags, Accessories, Stationary, etc.

*Some examples will vary from actual item.




Permitted Cases of independent Use of the Six Stars Symbol or SUBARU Logo *Permitted by exception

Independent use is permitted in the very exceptional cases below with the express consent of SUBARU. SUBARU CORPORATION must be contacted in advance. Submit a design draft and obtain approval before use.

*Some examples will vary from actual item.

(1) When using the Six Stars Symbol for a mobile terminal icon or favicon etc.


Display Example of Plant Signboards

C&B.I. Manual Applied Usage Edition 18 March 2019

The standard for plant signboards shall be the Tower Signs displaying Type C-V. Adjust and produce as appropriate according to the dimensions and configurations etc. of the actual mounting location.

Standard Pattern for Plant Signboards

The standard shall be to use separate boards for the C&B Logo and for the full company name/plant name. The background is to be white in principle.



How to arrange the Corporate Name Logo and plant name

Lettering for the plant name is to be smaller than the Corporate Name Logo. Even if the plant name has fewer characters than the Corporate Name Logo, maintain it at the same height or less.
